Terms of Use

Thank you for your interest in the Visualizing English Print services provided by the University of Wisconsin-Madison. By accessing or using the Visualizing English Print website (the “Site” or “Website”), you agree to be bound by the following terms and conditions governing use of the Site (“Terms of Use”). Use of the Website

The purpose of this Website is to provide an analytic tool for identifying patterns within written texts uploaded to the site by persons using the Site (“Users”). Users upload texts and determine parameters for analysis. The results of the analysis are either displayed on the Website or e-mailed to the User. The content of this Website is for non-commercial purposes only. You may only use the Website in accordance with these Terms of Use and may not use the Website to engage in any unlawful activity or fraudulent purpose or to infringe on the intellectual property rights of the University of Wisconsin or others.

Intellectual Property Rights
